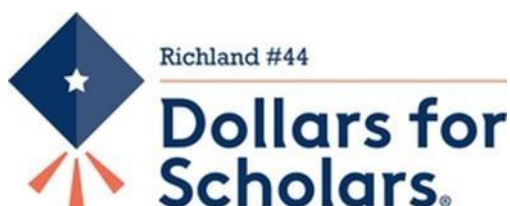

2023 Craft and Vendor Fair Information and Rules

1. Payment must accompany the application form or be arranged through Venmo.
2. An application is a commitment to show. Please notify us **before** Monday, November 6 if you are unable to attend. Dollars for Scholars is a non-profit organization and this is a fundraising event, therefore no refunds are typically offered unless the event is cancelled.
3. Only one vendor is allowed per national brand product such as Avon or Tastefully Simple.
However, it is not DFS's responsibility to bar vendors because they sell the same national brand product or if a vendor doesn't indicate that they sell the same brand.
4. Set up booths completely before start time on the date of the event and do not break down booths prior to the close of the event. Set up times will be 5-7 pm Saturday evening and starting at 7 am Sunday.
5. A single booth space is 10 feet x 10 feet. If you select two spaces, your booth size will be 10 feet x 20 feet.
6. **All displays and/or tables must be provided by the vendor.** There is no limit to the number of tables or displays units as long as the display racks and tables are placed within your own space.
7. Note on your registration form if electricity is needed – this may determine and will limit your location. Vendors should bring their own extension cord(s).
8. Please clean up your booth area before you leave. Dispose of trash in the dumpster outside the school.
