As colleges focus on student health and safety concerns due to COVID-19, college students are most worried about their personal finances, according to a national student survey conducted by Scholarship America®, the nation’s largest provider of private college scholarships.¹

Among the findings:

- ◆ 64% of student respondents said paying for school is one of their top concerns, while 42% of respondents listed contracting the virus as a top concern
- ◆ 77% said the pandemic has reduced their ability to earn income needed for their education
- ◆ 64% said the pandemic has increased their need for financial aid
- ◆ 30% of students surveyed said they have lost a job needed to help pay for college due to COVID-19, and 28% said a parent has lost a job

The survey was conducted from July 21-27, and included students currently enrolled in college or planning to enroll this fall.

Yet, in the midst of the year’s chaos, we are encouraged by the continued generosity of our donors and celebrate the following new annual scholarships.

Grinnell Mutual Group Foundation Scholarship – This permanent scholarship, established by the Grinnell Mutual Group Foundation, supports a student interested in pursuing an education toward a career in financial services, education, healthcare or agriculture.

BASF Malcom Scholarship – BASF We Create Chemistry – A world-wide chemical company with Headquarters in Germany and North America Headquarters in Florham Park, NJ. The company, in Malcom since 2012, is very involved in STEM (Science, Technology, Engineering and Math) education for students. Samantha Jo Kriegel Memorial Scholarship – Samantha Jo Kriegel was the daughter of LaVerne and Roseanne Kriegel and a B-G-M graduate of 1998. Sam was a fun-loving woman with a sense of adventure and willingness to try most anything. After graduating from UNI with a finance degree, she lived in Des Moines and then in Oklahoma City until returning to Iowa and living in Ankeny. Sam was a hard worker in the accounting field and as an accounting manager. Sam was always there for anyone needing help, so that is why the Samantha Jo Kriegel Memorial Scholarship has been established. Along with helping other young adults earn a higher education, she also was an organ donor and immediately helped save 5 other people's lives and more with tissue donation.



Bud & Elsie Kalinay Memorial Scholarship – Raymond “Bud” and Elsie Kalinay were strong advocates of B-G-M and everyone receiving an education. Elsie graduated from Brooklyn High School with the class of 1950. All 4 of their children, 3 of their grandchildren, and one great-grandchild have graduated from B-G-M. At the time this scholarship was created, 8 great-grandchildren were B-G-M students and in line to also be alumni. Their family awards this scholarship each year in their loving memory to assist those who wish to further their education.



Barbara and Bill Miller Memorial Scholarship – Barbara and William (Bill) Miller were longtime residents of Brooklyn. Both worked for the B-G-M school district during their lifetime and both were graduates of Brooklyn High School. Their four sons and three daughters also graduated from B-G-M. They were members of Grace United Methodist Church and strongly supported the Brooklyn Senior Center during their lifetime. They were active supporters of the community and participated in many support activities including Meals on Wheels. They also enjoyed playing golf at the Brooklyn-Victor Country Club. This award will support graduates who pursue an accounting education or were members of a B-G-M golf team.



Helyn and Richard Graham Memorial Scholarship – Helyn and Richard Graham were devoted farmers who lived 10 miles north of Brooklyn. Their farm has been in the family since 1876. Richard attended Brooklyn High School; all 5 of their children, 8 of their 14 grandchildren and 16 of their 28 great-grandchildren also attended B-G-M. Richard and Helyn knew the value of a good agriculture education and were supporters of Future Farmers of America. They were also active in square dancing and enjoyed Blue Grass music. As a result of their work and enjoyment, their memorial scholarship fund is awarded to those who want to further their agricultural education or education in the arts.

If there is no qualifying student, no scholarship will be awarded. 2) Barbara and Bill Miller Memorial Scholarship Fund – Preference given to Accounting/Business field of study or to B-G-M golf team member. 3) Bear Backers Athletic Scholarship Fund – Scholarships awarded to student athletes. 4) Betty Lippincott Memorial Scholarship Fund – Preference given to a BGM female golf participant. 5) Brandon J. Miller Memorial Scholarship Fund – Preference to a student who will be pursuing a degree in engineering or a form of agricultural education. - 19) **Hobart and Marian Powell Scholarship Fund**
- 20) **Irvin and Agnes Nervig Scholarship Fund** – Scholarship criteria includes intent of pursuing a four-year degree with class rank/GPA being adequate to qualify them to be admitted to an accredited college or university with preference to a student not already receiving a large dollar scholarship.

No interest is charged on loan until after graduation or when the student ceases going to post-secondary education.
- 44) **Operating Cost Fund** – A fund set up by the Board of Trustees to pay for the cost of operating the foundation each year.
- 45) **Preschool Scholarship Fund** – A fund set up to grant scholarships to 3 and 4 year olds who attend the BGM preschool.
- 46) **Project Mini-Grants Funds** – Grants to teachers in the school system to fund new ideas that can’t be funded through the school system. Grants made based on application from teachers with the approval of the school administration. You may elect to add your contribution to the following funds:

- 47) **Raymond M. Foster Second Year Scholarship Fund** – A scholarship fund set up for students extending their education beyond the first year. These scholarships will be available to students in their second consecutive year of school.
- 48) **John & Anna Gloe Edelen & Carma J. Mohler Third Year Scholarship Fund** – A scholarship fund was originally set up to redirect unaccepted scholarships after the two-year acceptance deadline. These scholarships will be available to students in their third consecutive year of school.
- 49) **John & Anna Gloe Edelen & Carma J. Mohler Fourth Year Scholarship Fund** – A scholarship fund set up for students extending their education to four years. These scholarships will be available to students in their fourth consecutive year of school.
